Application Area

Product Description

GREVEN[®] SOFT V is a mild cleansing lotion with good cleaning properties and excellent skin compatibility.

Product Properties

- The good skin compatibility is due to the balanced surfactant combination of GREVEN[®] SOFT V.
- Ether sulfate and betaine provide a mild base combination whose skin-friendly properties are significantly improved by glyceryl oleate. Glyceryl oleate is a lipid-balancing substance keeping the skin moisturized and supple.
- The pH-value of the product has been adapted to the natural acid mantle of the human skin.

AQUA, SODIUM LAURETH SULFATE, SODIUM CHLORIDE, COCO-GLUCOSIDE, GLYCERYL OLEATE, COCAMIDO-PROPYL BETAINE, GLYCOL DISTEARATE, SODIUM BENZOATE, POTASSIUM SORBATE, PEG-7 GLYCERYL COCOATE, LAURETH-4, FORMIC ACID, CITRIC ACID, PARFUM, CI 73360.

Application

Apply GREVEN[®] SOFT V evenly on the dry skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

Certificate of Dermatological Compatibility

The dermatological compatibility of GREVEN[®] SOFT V has been carefully tested and proven. A printed certificate is available.

Ecology

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

Statutory Regulations

GREVEN[®] SOFT V is subject to the Regulation (EC) No 1223/2009 on cosmetic products. Further details on handling the product can be obtained from the Group Data Sheets for skin products (for occupational use).

Storage Instructions

The product will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each bottle / canister.
